IN RE: ATTORNEY DISCIPLINE – IMPOSITION :
BY THIS COURT OF RECIPROCAL DISCIPLINE : **STANDING ORDER 2023-01**
PURSUANT TO L. CIV. R. 104.1 :

WHEREAS this Court regularly receives electronic notice that the New Jersey Supreme Court has imposed public discipline (including but not limited to disbarment, temporary or permanent suspension, censure, reprimand or admonition) upon attorneys admitted to practice before this Court; and

WHEREAS this Court may also receive notice of the imposition of public discipline upon such attorneys by the filing of a certified or exemplified copy of a judgment or order of another court of the United States or the District of Columbia, or a court of another state, territory, commonwealth or possession of the United States (“other courts”); and

WHEREAS attorneys so disciplined by the New Jersey Supreme Court and/or other courts (“disciplined attorneys”) are obligated, pursuant to L. Civ. R. 104.1(b)(1), to inform the Clerk and Chief Judge of this Court of such discipline within 20 days of the date of such order of discipline (“disciplined attorney notice”); and

WHEREAS this Court desires to give effectiveness to its imposition of reciprocal discipline and prevent the unauthorized practice of law in this Court; therefore

IT IS HEREBY ORDERED that:

1. Upon receipt of electronic notice by the New Jersey Supreme Court, or the filing of other courts’ judgments or orders in this Court (as provided in L. Civ. R. 104.1(1)(2)), or receipt of disciplined attorney notice, indicating that an attorney admitted to practice before this Court has been subject to public discipline, other than in the case of a censure, reprimand or admonition, this Court shall issue a notice to the disciplined attorney containing: (A) a copy of the judgment or order from the New Jersey Supreme Court and/or other court imposing discipline; and (B) an Order to Show Cause (“OSC”) directing the disciplined attorney to inform this Court within 30 days after service of the OSC why the imposition of reciprocal discipline by this Court would be unwarranted and the reasons therefor. In the case of a censure, reprimand or admonition, reciprocal discipline by this Court shall be deemed imposed and the matter closed.

2. Upon the failure of the disciplined attorney to timely respond to the OSC within the 30-day period, this Court shall enter an Order imposing reciprocal discipline upon the disciplined attorney forthwith.

3. In the case of disbarment or suspension, this Court shall change the disciplined

attorney's bar membership record with this Court and deactivate his/her CM/ECF Filing User account with this Court.

4. Disciplined attorneys upon whom this Court has imposed reciprocal discipline, as set forth herein, shall be ineligible to obtain a Certificate of Good Standing or a Letter of Ethical Conduct from the Clerk of Court.

5. Reinstatement of disciplined attorneys upon whom this Court has imposed reciprocal discipline shall be according to the provisions set forth in L. Civ. R. 104.1(g).

6. Pursuant to L. Civ. R. 104.1(b)(2), the above provisions of this Standing Order shall not apply to matters governed by L. Civ. R. 104.1(a) ("Attorneys Convicted of Crimes").

7. Attorneys admitted to practice before this Court are reminded of their obligation, set forth in L. Civ. R. 10.1, to advise the Court of any change in their address, within 7 days of being apprised of such change, by filing a notice with the Clerk.

8. This Standing Order is effective as of the date of this Order.
