The Special Master has determined that the plaintiffs in the cases listed on the attached Exhibit A appear to have become deceased after the date their complaints asserting claims for personal injury claims relating to the use of PPIs were filed but a motion to substitute the real party in interest has not been filed.

Within thirty days of the date of this Order, the plaintiffs' counsel in the identified cases are ordered to (1) file a motion to substitute the real party in interest for the deceased plaintiff, or (2) show good cause why they have not done so. Any named defendant may file a response within fifteen days thereafter. Failure to comply with the terms of this Order will result in the dismissal of the case.
