**CASE MANAGEMENT ORDER NO. 67
(Extension of Deadlines)**

Special Master Ellen K. Reisman hereby extends the deadlines set forth herein by agreement of the parties.

I. Case Management Orders (“CMO”) Nos. 52-53, 58-66:

- A. CMO No. 53 (Texas): The deadline for the Plaintiff Steering Committee to file their brief in response to Defendants’ submission is extended to January 10, 2022. The deadline for Defendants to file their brief in reply is set for February 9, 2022.
- B. CMO No. 52 (Michigan): The deadline for Defendants to file their brief in reply is extended to January 14, 2022.
- C. CMOs Nos. 58 and 64 (Orders to Show Cause regarding Decedents): The deadline for each individual plaintiff listed on CMO Nos. 58 and 64 to respond to the Orders to Show Cause is extended to February

15, 2022. The deadline for Defendants to oppose each plaintiffs' response is extended to April 1, 2022.

- D. CMOs Nos. 59 – 63, 65 - 66 (Service Orders to Show Cause): The deadline for each individual plaintiff listed on CMO Nos. 59 – 63 and 65 – 66 to respond to the Orders to Show Cause is extended to March 31, 2022. The deadline for Defendants to oppose each plaintiffs' response is extended to May 15, 2022.

II. Plaintiff-Specific Summary Judgment Motions:

- A. *Rieder* Statute of Limitations Amended Summary Judgment Motion: The deadline for Plaintiff Rieder to respond substantively to Defendants' Amended Summary Judgment Motion on Statute of Limitations (2:19-cv-00850, Docs. 43-44) is extended to January 10, 2022. The deadline for Defendants to file their summary judgment reply brief is extended to January 31, 2022.
- B. The deadlines for the respective Defendants to file their remaining plaintiff-specific reply briefs in *Bales*, *Foster*, *Holman*, *Kersch*, *Lee*, *Nelson and Rieder* are extended to January 10, 2022.

III. Preemption Summary Judgment Motions:

- A. The deadline for Defendants to respond to Plaintiffs' Motion for Leave to File Excess Pages (Master Doc. 727) is extended to December 27, 2021.
- B. The deadline for Defendants to file their summary judgment reply briefs is extended to January 28, 2022 and their page limits are extended to sixty-eight pages.

IV. *Daubert* Motions to Exclude:

- A. The deadline for Defendants to respond to Plaintiffs' Motions for Leave to File Excess Pages (Master Docs. 736, 740, 742, 744) is extended to December 27, 2021.
- B. The deadline for Defendants to file their *Daubert* reply briefs with respect to Plaintiffs' Expert Dr. David Ross is extended to January 21, 2022 and their page limits are extended to nineteen pages.
- C. The deadline for Defendants to file their *Daubert* reply briefs on specific causation is extended to February 11, 2022 and their page limits are extended to fifty-eight pages.

D. The deadline for Defendants to file their *Daubert* reply briefs on general causation is extended to February 11, 2022 and their page limits are extended to sixty-six pages.
